RULES AND CONDITIONS

BLUES, BERRIES & BBQ (BBB) & RICHLAND MUSIC FESTIVAL (RMF)

- 1. An accepted application is a commitment to show and constitutes the agreement between the parties, vendor, and BBB or RMF. No refunds will be made for cancellation or inclement weather. NO EXCEPTIONS.
- 2. Vendor is restricted to setting up in the space designated by BBB or RMF. Space assignments are made by the Committee Members. Any vendor caught setting up in any other area will be asked to leave the premises, will not be allowed to participate in future events, and will forfeit all fees.
- 3. Vendors are not allowed to park behind their booth or in the surrounding streets that are closed off for patron traffic. Any vendor parked in these areas will be asked to leave the premises, will not be allowed to participate in future events, and will forfeit all fees.
- **4.** Single booth space is a maximum of 10'x10'. All exhibitors must have WHITE TENTS. Anyone that sets up a tent of any other color will be asked to leave and will forfeit all fees.
- 5. Vendors must provide their own WHITE TENT, weights to anchor tents, cooking and storing equipment, 8' tables, and chairs. They are responsible for the assembly and disassembly of all items. Prepare for the possibility of inclement weather conditions such as rain or wind.
- **6.** Vendors are required to serve food and beverages according to the BBB and RMF schedule, unless prior arrangements have been made, in advance, with BBB/RMF, and must staff their booths and food trucks during Festival hours.
- 7. Vendors bear the responsibility for all setup and security needs for their booths. BBB or RMF will not be responsible for any loss or damage and the vendor will indemnify and hold BBB or RMF harmless for any loss or damage to any of the vendor's property or any damage or loss sustained by a third party due to installation or set-up by vendor.
- 8. The sale of tobacco items, smoking accessories, drug paraphernalia, sexually explicit items, CDs, T-shirts (including tie-dye), DVDs, cell phone accessories, lighters, and sunglasses are strictly prohibited. Any exhibitor caught selling these items will be asked to leave the premises, forfeit all fees, and will not be allowed to participate in upcoming events.
- **9.** All vendors certify that they will cooperate with all standards and procedures, insurance requirements, and all state and city laws and ordinances pertaining to food service and tax reporting.
- 10. Vendors are required to get approval for music, loud speakers, or megaphone devices.
- 11. All requests or special needs must be made in writing and received with completed application. All efforts will be made to honor such requests; however, BBB or RMF cannot guarantee that all requests will be granted.
- 12. All exhibitors are responsible for reporting their own applicable taxes including income and state and local sales tax.
- 13. All vendors further agree to indemnify, defend, and hold harmless the Blues Berries & BBQ and/or Richland Music Festival from any and all claims, demands, loss or liability of every nature, for injuries to persons and/or property, or occurring in or about or in any way connected with this Application or Agreement, BBB or RMF, or their service or any performance of their obligations under this Agreement or Application, to the extent such claims, demands, loss or liability arise out of the negligence or failure of the exhibitor, its officers, agents, employees, representatives, vendors, subcontractors, assigns, licensees, and/or invitees.

In the event of any claims, demands, loss or liability arising under this section and their duty to defend, the exhibitor's responsibility shall include the payment of all reasonable attorney's fees and all coses of defense and/or litigation, mediation, arbitration, or any other similar claims process initiated under this Section. **See additional food vendor details below and signature requirement.**

BLUES, BERRIES & BBQ (BBB) & RICHLAND MUSIC FESTIVAL (RMF)

ADDITIONAL RULES FOR FOOD VENDORS ONLY:

- Each vendor must submit a full application and will be accepted on a first come. first serve basis and at the discretion of the Festival Committee.
- · Vendors will serve portions with the recommended price not to exceed \$10.
- No more than two vendor shall be allowed to serve the same menu items as other vendors and the Committee must approve all menu items.
- Vendors using grease are required to have some form of covering underneath cookware to prevent stains on public property.
- Vendors must dispose of waste in appropriate, predetermined areas.

PROVISIONS

- · Booth vendors must provide their own power cords and the power source will be within 75' of booth space.
- · Food trucks will be responsible for their own power (run on their own generators).
- Vendors will be mentioned periodically on stage throughout the festival.

If you are selected as a vendor, and you elect to participate, booth fees are payable and due no later than May 31, 2018. They are non-refundable.

Terms and conditions *

I have read and understand all terms and conditions outlined in the 2018 Blues. Berries and BBQ Festival and Richland Music Festival Rules and Standards. By executing this application. I represent that I have read and understand all terms outlined in the 2018 Vendor Rules and Standards and agree to be bound by those terms. as they represent the contract between the parties. No other agreement shall be binding between the parties unless in writing and signed by an authorized representative of the Blues, Berries and Barbeque Festival or Richland Music Festival. Further. I understand that the Blues. Berries and BBQ Festival or Richland Music Festival may, at any time, amend the terms of the agreement to be effective immediately or as otherwise specified and participants agree to comply. Finally, I understand that the Festivals will not issue credits or refunds to any vendors in cases of inclement weather.
